#### **SUMMARY**

My career has spanned over thirty years with a focus on social and political developments in South Africa. In the 1980s, I worked on Senator Edward Kennedy's foreign policy staff. For 14 years, I worked at the C. S. Mott Foundation, opening their South Africa office and directing a programme that focused on human rights and strengthening the non-profit sector. Over the past decade, I have worked as a writer – writing articles and case studies as well as publishing two books of narrative non-fiction: Sanctuary (Jacana 2013) about migration and xenophobia in downtown Johannesburg, and Darwin's Hunch (Jacana 2016) about the history of the search for human origins in South Africa within a changing social and political context.
